## 1. INTRODUCTION

Zimbabwe Health Interventions (ZHI) is a not-for-profit human development organization which is registered as a Private Voluntary Organization PVO Number 17/22. ZHI's mission is to develop and deliver innovative and sustainable high impact integrated health interventions with local communities while working with and strengthening existing institutions.

## 2. OBJECTIVES OF THE ASSIGNMENT/ TERMS OF REFERENCES TORs)

ZHI provides comprehensive medical insurance cover to all full-time employees and their spouse and unmarried children up to 18 years of age, or up to 23 years of age if enrolled as a full-time student, up to a maximum of 4 children.

ZHI employees are based in Harare, Buhera, Chipinge, Mutare, Mutasa, Makoni, Gweru, Kwekwe, Gokwe South, Mberengwa, Bulawayo; Gwanda, Beitbridge, Matobo, Insiza, Mazowe, Plumtree (Mangwe and Bulilima) with a staff complement of approximately 350 employees on medical insurance.

Now, ZHI wishes to contract a reputable and eligible Medical Health Insurance company, to provide medical services cover for its employees and their dependents. Bidders are requested to propose the best and most cost-effective solution to meet ZHI requirements, while ensuring a high level of service as provided for in the attached Terms of Reference (ToRs).

The applicant companies should provide quotations for the insurance cover to cater for a minimum of but not limited to the following categories of benefits:

- Outpatient services
- Inpatient services/hospitalisation requirements
- Special coverage conditions
- Additional benefits required.
